Friends,

While many of us are considering buying an electric razor as a holiday gift, workers at the Norelco factory in Roselle, IL are having their rights shaved away.

The employees at the assembly and distribution center in Roselle are paid as little as \$70 for 11 hour work days, while the razors they make are sold at Walmart for \$189.97. In one shift, 200 workers from the temporary employment agencies that staff the Roselle facility create about one million dollars worth of razors. These workers face illegal retaliation for calling in sick and they have been victims of unfair labor practices for reporting the poor conditions inside their workplace.

Like Scrooge, Norelco's staffing companies are forcing their employees to spend less time with their families this holiday season, as they are made to report for work early -- without being paid.

The Norelco workers have been organizing with the Chicago Workers Collaborative, but they need our help and solidarity.

As concerned consumers we can make a difference, it is time that big box retailers like Walmart have ethical supply chains.
